Friends of the Shenandoah River's 2021 Summer Quantitative *E. coli* Test Results at public recreational use sites on the Main Stem, South Fork and North Fork of the Shenandoah River and the Opequon Creek

These results provide a snapshot of the *E. coli* bacteria concentrations at the designated sites on the date, time, and under the conditions that the water samples were collected.

Previously, Virginia's water quality standard for freshwater beach advisories or closures was a single sample maximum of 235 *E. coli* CFU/100 ml of sample. Virginia no longer has a single, instantaneous, sample maximum or any criteria for primary recreational contact in freshwaters.

Red indicates that the *E. coli* concentration exceeded 235 *E. coli* CFU/100 ml,
