RED indicates the *E. coli* concentration exceeded the US Environmental Protection Agency recommended precautionary "do not exceed" Beach Action Value (BAV) of 235 CFU of *E. coli* bacteria per 100 mL of water sample for early alert to freshwater recreators, including families with children.
